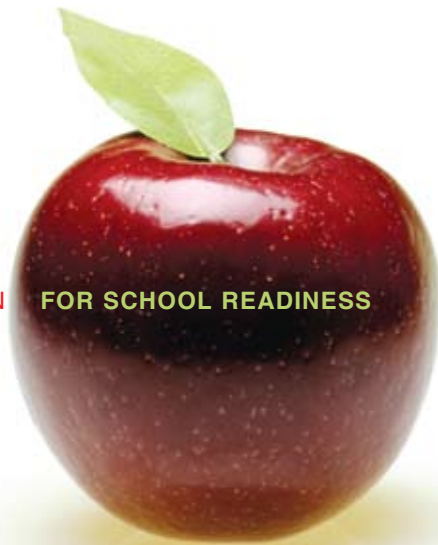

Message from the Board Chair

Even with such exciting times ahead, it's important for us to reflect on our past. The 2007-2008 fiscal year brought many challenges, many triumphs, and even some small revisions.

We started the year with modifications to our logo, vision, and mission statements. We gained momentum from implementing a successful annual campaign, the first organized effort of its kind at Smart Start of Forsyth County. We are proud to say that 100% of the board of directors and staff of Smart Start of Forsyth contributed to the Building the Foundation Campaign. We are especially pleased to have gained new friends through the campaign.

The most exciting occurrence came in the form of progress in the field of quality early education. More children than ever before were served by our programs and received the education or health intervention they need to be prepared for kindergarten. The quality of the child care facilities continued to rise; this year our county's child care facilities achieved an average star rating of 3.42 on the 5-star rating scale, a Forsyth county high!

This past year was full of celebrations honoring those who work hard to support young children in our community. We recognized our high-achieving child care providers at the inaugural Provider Recognition Event. We also recognized our volunteers for the contributions they have generously made to the organization through our allocations process and all of our special committees.

With all that said, we still have many more challenges ahead, but we are prepared to put all of our forces to work in order to prepare all young children for school and life-long success through community partnerships.

2007-2008 Accomplishments

Educators:

- 1428 child care professionals attended a Smart Start training or workshop
- 217 child care professionals enrolled in a college-level early childhood course
- 365 child care professionals received Smart Start salary supplements



Smart Start of Forsyth County Our Programming Values

Smart Start values quality early education and access to child care.

Smart Start values families and the role they play in a child's growth and development.

Families:

- 11 Parent Educators worked with 542 children in the More at Four program
- 330 teen mothers received individual consultation from the school social worker for teen mothers and their children
- 1728 families received child care resource and referral services

Child Care and Quality Education:

- The More at Four program expanded by nearly 20% offering 560 subsidized preschool slots
- 282 families with 362 children received child care subsidies
- 53 families with 66 children received emergency child care assistance

Child Care Facilities:

- 21 child care centers and 19 child care homes participated in Smart Start activities designed to increase their rating to 3 stars or higher
- 28 child care centers and 93 child care homes participated in Smart Start activities designed to maintain their current rating of 3 stars or higher
- Child care centers participating in Smart Start activities designed to increase their star rating had a staff retention rate of over 90%

Health:

- 5747 children received oral health assessments
- 835 children were screened for developmental delays
- Interpreter and translation services were provided to 77 new pediatrics patients and 61 new obstetrics patients per month

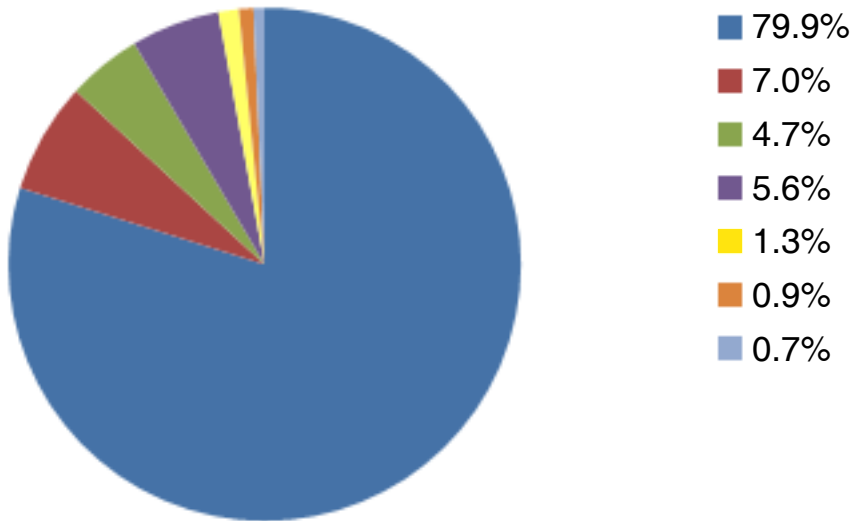
